As the world continues to adapt to the new reality imposed by COVID-19, Villa Colombo Toronto (VCT) remains committed to ensuring the safety and well-being of our residents as well as the people who care for them – our staff. During these extenuating circumstances, the entire staff at VCT is working around-the-clock to prioritize the health and safety of our beloved residents. They ensure that all residents continue to receive the care they require and deserve and facilitate assistance so they may stay connected with their loved ones via phone/video calls and window visits. Our staff continue to go above and beyond the call of duty and we acknowledge that they, too, require our support and appreciation as they continue to risk infection every day. We are blessed to have such committed and dedicated staff (including contract partners and physicians) whose compassion, skills, and abilities are put to the test daily.

This crisis has changed our lives and challenged our views on what we once took for granted as a community. Direct donations through the Villa Colombo Toronto Auxiliary (VCTA), a significant source of funding, are at risk. The necessary cancellation of two of the VCTA's scheduled premier events – Spring Pasta BINGO and the 31st Annual Golf Tournament (our largest fundraising event of the year) – will result in a revenue shortfall of approximately \$40,000 in 2020.

To compensate for this significant loss, the VCTA is launching a fundraising campaign to support COVID-19 safety measures which will enhance the protection of our residents and front-line staff. As COVID-19 continues to escalate and as more seniors and staff become vulnerable to the virus, we anticipate the demands for safety measures to increase. VCT is taking extraordinary steps to protect the health of residents and the staff who care for them. Your generous donation will enhance quality resident care and ensure the delivery of appropriate services, programs, and activities, within a home environment that keeps the residents safe, engaged, and comfortable. 100% of the funds raised through this campaign will be directed towards supporting resident care, as well as supportive gestures of staff appreciation to acknowledge their ongoing efforts and boost their morale.
